I-Promise Graduates

In 2012, a total of 91 I-Promise students who entered in 2008 graduated with a B.A., B.S. or B.F.A. degrees. Combined with other cohorts of I-Promise graduates, there are now 526 alumni

The chart to the left shows the percentage of I-Promise students in different cohorts (2005-2008) who graduated.

Slightly more than half of I-Promise students graduate in four years, with 73-75% graduating within five years. For those cohorts where six-year graduation data are available, an additional three percent of students graduate.

Research

In 2012, research continued in two areas. First, a study was conducted on how well the mentoring component of the program works, based on mid-year and end-of year surveys over the past two and a half years. In addition, first-semester GPA and freshmen retention were included as measures. The majority of mentees (70%) reported that their mentor helped in easing the transition to college. Also, students with mentors earned a higher first-semester GPA than did students without mentors. Students with mentors also exhibited a higher freshmen retention rate. However, because the data are correlational, it is not possible to draw firm causal conclusions. Mentoring could enhance academic performance or, alternatively, better performing students may be more inclined to seek mentors. Further analysis is needed.

The second research project examined graduation rates of underrepresented and/ or low-income students admitted to Illinois in 2005 and 2006. Preliminary results suggest that the first-semester GPA is crucial in predicting graduate rates. At present, interventions occur when students are on academic probation (generally at or below a 2.0 GPA). This study revealed that students with a first-semester GPA in the range of 2.0 to 2.3 also are at risk of not graduating. Future work will explore GPA throughout the first two years to better understand when academic support is most needed.

MENTORING

The purpose of the mentoring program is to help ease the transition to college for freshmen and transfer students. Since its inception in 2009, the mentoring aspect of the program has grown from 29% to 45% voluntary participation by students. Orientation training for mentor and mentees, ongoing support, opportunities to

develop skills, and community-building events are features of the I-Promise mentoring program. Mentors make a one-year commitment to serve in this role, but several mentors and students (like Pat Justice with mentee Loreal Latimer in the photo below) continue their connections year after year.

PROGRAM OVERVIEW

Illinois Promise is an access scholarship program initiated in 2005 to provide high achieving, low-income students an opportunity to attend the University of Illinois at Urbana-Champaign. Educational expenses, including tuition, fees, room and board, and books and supplies are covered. In addition, enrichment programs are offered to foster student success.

Students do not apply to become an Illinois Promise scholar. Rather, students gain admittance to the University of Illinois at Urbana-Champaign, complete the FAFSA (Free Application for Federal Student Aid), and then the Office of Student Financial Aid determines eligibility based on the following criteria:

- Illinois residency
- Under the age of 24 and admitted as a freshman or transfer student
- Family income at or below the federal poverty level (\$22,350 for a family of four)
- Family assets of less than \$50,000 (does not include the home)

• The Expected Family Contribution (EFC) equal to \$0

• Minimum enrollment of 12 credit hours during fall and spring semesters

Funding the program takes a team

approach. I-Promise students receive federal, state, institutional and/or private grants and scholarships for which they qualify. The Illinois Promise award is based on the difference between the students' cost of attendance and other financial aid received. I-Promise funding is provided from institutional resources as well as private funding from individuals and corporate donors. In academic year 11/12, Illinois Promise funding totaled \$4,162,939; the average award per student was \$6,505.



The I-Promise program, its supporters, and the student/alumni mentors are truly making a difference on campus. The program encourages students to form lifetime relationships with mentors and students and empowers students to excel academically. I am grateful that I had I-Promise as a resource, and I am excited about the continued success and impact the program will have on students."





Students Served in the Illinois Promise Program




Enrollment of Illinois Promise Students by College -Academic Year 11/12

Students' Sense of Community Within I-Promise




Chart combines student responses indicating they were "happy", "very happy" or "thrilled" with the sense of community within I-Promise
